

## TheDarkStranger.Com Booking Agreement - Clubs

To complete the booking process for your event, please complete the following steps:

1. You have been given a rate for entertainers based on the number of entertainers and the length of your commitment to use our services. Your payment of the deposit confirms your booking for the date(s) requested. The rate and terms of our services are to be discussed with DarkStranger, his assistant and/or designated representative. DarkStranger will provide instructions for payment and other event business if he does not attend the event.
2. You agree to pay 50% of balance 72 hours before the show and pay the remaining balance to DarkStranger or designated representative when the entertainers arrive for your event. To help offset gas/travel costs, you may be asked to add additional fees to help with travel cost. Please include that amount in the appropriate field on the agreement below and make arrangements to pay this amount prior to the day of your event.
3. Every attempt will be made to provide the entertainer you requested. However, we reserve the right to substitute. We will discuss any changes with you in advance.
4. Your deposit will be refunded if we are not able to provide you with entertainers for your event.
5. ANY cancellations by client will result in forfeiture of deposit. Cancellations within 72 hours of the event will result in forfeiture of deposit and will require full payment of all booking fees and expenses incurred for all entertainers scheduled.
6. Entertainers are not obligated to perform for same gender parties or to perform any other acts that the entertainer is not comfortable with.
7. Entertainers should not be asked to be involved in any type of prostitution or other illegal acts. Client is responsible for knowing and following laws for adult entertainment in their city/state.
8. Entertainers are not to be photographed or videotaped unless prior arrangements are made.
9. The client, partners, affiliates, family and/or other representatives agree not to release photos and/or video of the entertainers for public viewing, publication and/or distribution without prior written/verbal permission of TheDarkStranger.Com.
10. Client will provide one hotel room for every 2 entertainers when entertainer travels more than 100 miles from current home office.
11. Client agrees to provide quality system with CD/DVD Player to play entertainer's music. CD players on computers or laptops are not acceptable.
12. I agree to add \$50 to costs for event when the entertainer provides their own equipment. We require at least 7 days notice for this request.
